Two charity events was organised in June 2015 (Gala Dinner) and November 2015 (Golf Tournament) to raise money for the Patient Subsidy Care Fund. A total amount of \$563,980 was raised from these two events.

### REVIEW OF FINANCIAL STATE AND EXPLANATION OF MAJOR FINANCIAL TRANSACTIONS

The Foundation has a surplus of \$312,307 in FY2015, with cash at bank of \$492,603 as at 31 Dec 2015.

Top 3 donors are Tote Board (\$50,000), John Lim, an Exco Member, (\$30,000) and SymAsia Singapore Fund (\$15,000) respectively whilst top 3 payments to vendors were Campaign Technologies Pte Ltd (\$35,567), Pan-Pacific Hotel (\$33,545) and Raffles Country Club (\$25,808).
